Reduces submission deadline for board and commissioner's report evaluating all aspects of the performance of the hazardous waste regulatory program. Part of Administration Package.

Makes changes to the Water Quality Control Act by no longer requiring compensatory mitigation in association with watershed activities that are conducted in accordance with a site-specific design developed through full application of the Natural Resource Conservation Service (NRCS) Conservation Practice Standard 580 (Tennessee), conducted in accordance to the NRCS Engineering Field Handbook, Chapter 16 Streambank and Shoreline Protection and subject to NRCS over site as a federal action.

Prohibits schools from denying students' ability to bring clear water bottles on campus.
